# TILA TOP UP® Privacy Policy

Tila Top Up® held by Prasan Enterprises Inc (hereinafter "TILA TOP UP®") is committed to the protection of its users' privacy and aims to protect its users against the misuse of their personal identifiable information to third parties. The Privacy Policy below, which is incorporated to the Terms and Conditions, explains the practices that apply to your TILA TOP UP® Registered User Account information, as well as the privacy setting you choose to protect and share information as well as used on the website generally.

TILA TOP UP® will not sell or share your personally indefinable information unless you have authorized such use.

When using our website, mobile application and Registered Commercial or Purchaser Accounts, you consent to the collection, transfer, manipulation, analysis, storage, and disclosure about you and other uses of your Registered Commercial or Purchaser Accounts, purchase habits or website visit as described in this Privacy Policy. Irrespective of which country that you reside in or create information from, your information may be used by TILA TOP UP® in the United States or any state where TILA TOP UP® operates.

Upon registering a Registered Commercial or Purchaser Account with TILA TOP UP®, you will be asked for certain personally identifiable information such as but not limited to your full name, business name, username, email address, mailing address, telephone number, and/or credit card or debit card numbers. # PRIVACY POLICY ADDITION FOR CALIFORNIA

# <u>California Consumer Privacy Act of 2018, as amended, (CCPA) and compliance with CCPA regulations.</u>

Data Privacy and Rights for California Account holder and internet Users. In compliance with California law and regulation concerning privacy, the following privacy policies apply to our use of personal data collected on our website, through our mobile application, and within our account portal with regard to California residents and households.

**PLEASE BE AWARE**. TILA TOP UP, INC collects user data on our websites (<u>TilaTopUp.com</u>; <u>TilaRetail.com</u> and <u>TilaAdmin.com</u> and the *Tila Top Up® Mobile Application*) to improve our services, enhance and improve our user experience, and understand the consumers who interact with our website and how they find us and our services. We interface with online marketing to find our landing pages and links from our social media campaigns directing website browsers to

our landing page and service offerings. This is used only for our own marketing and analytics. We **<u>DO NOT</u>** sell or commercialize or sell personal data or profile data of website browsers. We maintain written policies on the collection, internal use, storage and disclosure of personal data in our regular business. We **<u>DO NOT</u>** use web trackers or beacons. As a California resident who visits our websites, purchases from us online, or maintains a user account through the Tila Top Up® Mobile Application, you have the following rights that we observe:

Right to know what personal data we collect. Some of the data we collect may be information that identifies, relates to, or could reasonably be linked with you or your household. Some of this information is essential to us providing the services we provide you. This includes cellular telephone number(s), area codes of those telephone numbers, email address, records of services you purchased, internet browsing history, Social Media referrals, credit or debit cards numbers, bank information. Some of this information under the CCPA could be used to reasonably create a personal profile about your characteristics or preferences, to some extent, either in whole or in part. Some of this information includes Sensitive Personal Information under the CCPA including account log-in, financial account, debit card, or credit card number with any required security code, password, and your user credentials. This information will only be used by TILA TOP UP, INC for internal purposes in the performance and marketing of our service. **Right to Deletion, Correction or Opt-out**. As a California resident and user of TILA TOP UP, INC's services the following apply:

- 1) As a website browser of our websites, you may request Deletion. Correction and/or Opt-Out of our data for our internal purposes. In the event of a data breach, TILA TOP UP, INC will give applicable notice to the public as prescribed by law.
- 2) As a Customer or Retail user of our websites or portals, Sensitive information about you or your business is essential to the performance of our services. So far as you are a customer, use the mobile application, or have an open account, this information may not be deleted without frustrating the operation of our services. Opt-out of the use of this Sensitive Data is not available but may be requested as a part of closing you account, Correction of Sensitive Data may be performed through your account by you directly. Retail users, who are businesses and provide information that does not have the potential to identify a California household, or resident individually, is subject to exclusions under the CCPA.

TILA TOP UP, INC does not discriminate on any basis its compliance with the CCPA or with regard to any request from a California resident as related to a California household.

## **Our Policy towards Children**

In addition, personal information that you submit for publication on the website will be published on the internet and may be available around the world. In such cases, TILA TOP UP® is required to supply this information in accord with the request.
